## FINPEDMED Service Fees – Valid for year 2026

FINPEDMED Service Fees for Consultations (i.e. Expert Assignments) are based on Service Requests filed by a Requester; i.e. pharmaceutical companies, Biotech Companies, Contract Research Organizations (CROs), competent authorities, or other parties, related to pediatric drug development or pediatric clinical trials. The Clinical Research Institute HUCH Ltd. administrates the invoicing of the Service Fees. The FINPEDMED Service Fees are total sums. The Service Fee covers all costs incurred by Institution in relation with the Services performed according to the Terms of FINPEDMED Services. Any applicable value added tax (VAT) or similar taxes will be added to the invoice. The rate and amount of such VAT shall appear on the invoices for payment. For academic projects, service is provided free of charge. All consultations are conducted under tripartite Consultation Agreement, which is signed by the Requester, Expert and the CRI HUCH Ltd.

Description of the Consultant Service Category	Duration (Expert work)	Service Fee
<b><u>Category 1: Basic Feasibility Assessment by individual expert</u></b>  Includes expert evaluations in case of the single short-term task: Assignments such as simple pre-feasibility questionnaires or single medical opinions. Does not require familiarization on the subject. Includes basic Service Request responses, whether the investigator is interested in the proposed assignment or not.	Less than 1 h	Free of charge in 2026.
<b><u>Category 2: Consultations (Fee-based hourly services) – Hourly based expert work by individual expert. Includes also very extensive Feasibility Assessment and Expert Reports.</u></b>  Includes expert work in various kinds of assignments in the field of drug development, evaluating and reviewing research protocols, PIPs, or other similar and additional task related documentation. This may include more detailed feasibility assessments, written statements in the form of subsequent Expert Reports or other similar documents, such as national reimbursement statements or equivalent reports to regulatory agencies. Requires in-depth familiarization and retrieval of information on the subject beforehand. The place for performing the tasks is Finland. This includes also participation in teleconferences or face-to-face meetings, invited speaker's events, conferences, meetings or events which may involve negotiations, as an active participant based in Finland (Expert's location). If activity needs travelling, the requester covers these travel costs for the expert. Ad hoc Scientific Boards can be called on the assignment basis and that may include Experts from various fields of expertise.	From 1 full hour to max. 8 h per one request.	<b>400 €</b> per every beginning hour per expert per one Consultation work / single activity per case.
